**TESTING**

Call your health care provider first or if you are symptomatic to determine the need for testing. If a person thinks they have COVID-19, they should call their health care provider before going to their office so the provider can take precautions to prevent exposing other people. In some cases, they are going to meet you in the parking lot. It's just a precaution. We are really trying to keep our healthcare workers safe. Other patients safe. Review your signs, symptoms and travel history with your physician. Your provider is going to evaluate you for possible causes and rule out other respiratory illnesses (ex. Flu) before testing for COVID-19.

## **CLOTH FACE COVERS/MASK**

The CDC recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain (e.g., grocery stores and pharmacies) especially in areas of significant community-based transmission. It is important to note that these face coverings:

1. Are not surgical or N-95 respirators, which continue to be reserved for healthcare workers and medical first responders, and
2. The use of cloth face coverings does not mean we can remove previously set social distancing measures.

#### **TRAVEL UPDATE**

Cases of coronavirus disease (COVID-19) have been reported in all states, and some areas are experiencing community spread of the disease. Travel increases your chances of getting and spreading COVID-19. The CDC recommends you [stay home](#) as much as possible, especially if your trip is not essential, and [practice social distancing](#) especially if you are at [higher risk of severe illness](#). Don’t travel if you are sick or travel with someone who is sick. Residents from Connecticut, New Jersey and New York are still advised to isolate or quarantine for a 14 day period from the time of entry into Florida or the duration of the individual’s presence in Florida, whichever is shorter. Short term rentals in Franklin County are reopening this week. Franklin County's plan for reopening includes a ban on renting to overseas travelers during the first phase, or to any person who lives in an area with substantial community spread of COVID-19. ## **UNEMPLOYMENT COMPENSATION**

On, Thursday, April 16, 2020 Governor DeSantis issued Executive Order 20-104 which suspends the requirement that Floridians must recertify reemployment assistance status every two weeks.

## **FORECLOSURES & EVICTION RELIEF**

On April 2, the Governor also issued Executive Order 20-94, providing targeted, temporary relief from certain mortgage foreclosures and evictions for 45 days, without relieving an individual's obligation to make mortgage payments and rent payments.

### **BOCC UPDATE**

### **COUNTY CLERK & COURTHOUSE OFFICES**

### **HEALTH DEPARTMENT**

Starting May 28, 2020, the Franklin County Health Department will resume full clinic services. This includes annual physical exams, well woman exams, Florida Breast and Cervical Cancer Early Detection Program, and other routine appointments. Some services will continue to be done curbside or over the phone to decrease unnecessary exposure. Please call (850) 653-2111 to schedule an appointment! Please do not bring visitors with you to your appointments.

### **CITY GOVERNMENTS**

On May 18, 2020 the City of Carrabelle administrative staff will return to regular business hours at the City Hall however only the lobby will re-open to the public. All non-essential meetings will be conducted by phone until further notice. The public is encouraged to continue to use the Dropbox at the front of City Hall for water & sewer payments.

The Carrabelle City parks are now open however playgrounds and public restrooms will remain closed until further notice.

## **CLEANING DISINFECTING SAFETY**

The daily number of calls to poison centers increased sharply at the beginning of March 2020 for exposures to both cleaners and disinfectants. To reduce improper use and prevent unnecessary chemical exposures, users should always read and follow directions on the label, don't mix chemicals, wear protective gear, use in a well-ventilated area and store chemicals out of the reach of children. ## **WHAT SHOULD I DO IF I RECENTLY TRAVELED TO AN AREA WITH AN OUTBREAK OF COVID-19?**

If you are returning from an area with an outbreak of COVID-19, the CDC is recommending you self-isolate for 14 days immediately upon returning from your travels, even if asymptomatic (no symptoms). Follow the CDC steps to help protect other people in your home and community: <https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html>

If you develop a fever and symptoms of respiratory illness, such as cough or shortness of breath during those 14 days, contact your health care professional and mention your recent travel. Your provider will work with the health department to determine if you need to be tested for COVID-19. If you have had close contact with someone showing these symptoms who has recently traveled from an impacted area, you should call a health care professional and mention your close contact and their recent travel.

## **HOW LONG DOES IT TAKE TO RECOVER FROM COVID-19?**

Most individuals who test positive for COVID-19 are able to recover at home. Individuals will be asked to remain at home, except to get medical care. Stay in touch with your doctor if you feel worse or you think it is an emergency. People with COVID-19 who have stayed home can stop home isolation after meeting ALL of the following conditions:

- You have had no fever for at least 72 hours (that is three full days of no fever without the use of medicine that reduces fevers)
- Other symptoms have improved (for example, when your cough or shortness of breath have improved)
- At least 7 days have passed since your symptoms first appeared

A test-based strategy is preferred for discontinuation of transmission-based precautions for patients who are hospitalized or severely immunocompromised or being transferred to a long-term care or assisted living facility.
