#### **MEDICAL STAFF REPORT**

Patrick Conrad, MD

- Dr. Jeffrey Johns is back on staff with Southland. He is picking up an occasional shift at Weems.
- Flu cases, mostly pediatric, are being seen through the ER.
- New COVID variant, Omicron, seems to have milder symptoms.

#### TMH MEDICAL PRACTICE UPDATE

Lauren Faison-Clark, TMH Administrator Regional Development, Population Health and Telemedicine

- Dr. Newton's volume continues to increase.
- TMH is working with Weems to increase patient access to medical care. Current projects in Franklin County include:
  - Diabetes care and education via telemedicine. (Staff are being trained now.)



- o Increased access to behavioral health via telemedicine
- Remote patient monitoring solutions
- TMH will be scheduling Peer Network days in 2022
- TMH is driving local swing bed referrals. Lauren would like to propose a business plan to TMH that would dedicate one case management nurse for rural partners. Harrison requested an update next Board meeting on progress.
- Comm. Boldt quested the opportunity for dialysis services in Franklin County. Per Lauren, data is being extracted to determine number of Franklin County residents in need of dialysis. Once data is available, it will be evaluated for potential dialysis services in the county.

# **CLINICAL SERVICES REPORT**

Courtney Alford, DON

- Flu cases are being seen. Most have been pediatric.
- Positive COVID 19 cases are remaining low.
- Staffing shortages have been mitigated with 3 travel nurses. The seasonal low census has also helped.
- Walker introduced Haley Williams, Radiology Manager, to the Board.

- The Community Paramedicine program is up and running.
- Dr. Redfield will assume EMS Medical Director duties on 12/18/2021. Prior to now, Dr. Conrad served as the Medical Director for several years.

# HR REPORT

Ginny Griner, HR Director / Medical Staff Coordinator

- Travel assignments continue in the nursing and laboratory departments. The lab recently contracted with 2 Med Tech travelers. An offer has been extended for permanent, full-time position to a Med Tech candidate.
- Recent new hires were made in nursing, radiology, maintenance, and dietary departments.



- To meet CMS mandate, Weems has developed a COVID vaccination policy, established processes and record keeping procedures.
- The Medical Staff Committee will meet in January 2022.
- A discussion was held regarding staff shortages. Contributing factors in these shortages include vaccination mandate, higher pay rate with travel opportunities, RN graduates pursing online APRN degrees, and shortage of instructors for nursing programs. Walker mentioned that there may be future legislation for student loan forgiveness.

# **CEO REPORT**

David Walker, CEO Action Items

• COVID Vaccination Policy: CMS has issued a COVID Vaccination Mandate for health care facilities who participate in their Medicare and Medicaid programs. The interim final rule requires health care facilities to develop plans and processes to vaccinate all current staff. The final rule also includes vendors who provide services in the facility. The first vaccination dose must be received by December 6, 2021, and full vaccination by January 6, 2022. The plans must accommodate medical and religious exemptions as well. Weems will comply with the CMS mandate because we receive federal funding from CMS to serve the medically vulnerable. Board recommendation to approve the COVID Vaccination Policy to meet CMS guidelines.

## **Discussion**

Eleven states have a stay from the CMS mandate. Florida's request for temporary injunction was denied.

Comm. Boldt quested follow up on exemptions, i.e., masks, weekly testing, etc. Walker discussed the current mask policy.

# Informational Items

- Congressman Neal Dunn visited Weems on November 2, 2021 to discuss issues facing rural counties. Commissioner Jones, Courtney Alford and Walker met with the Congressman and staff. Low-Income Pool (LIP), Disproportionate Share Hospital (DSH) and federal funding for rural hospitals was discussed.
- Walker attended the Franklin County Legislative Delegation Hearing on November 10, 2021 to ask local legislative delegation to support our funding request from the 2022 FL Legislative Session to build a new facility. Senator Ausley was in attendance. Representative Shoaf was not present, but his staff was in attendance.
- Options for another Electronic Health Record are being reviewed. Evident, a CPSI software, has been identified. Daniels has conducted a financial analysis and components to be included in the E.H.R. are being identified. A recommendation will be brought to the next Governing Board meeting.
- Jim Coleman will give an annual Alliant update to the Franklin County Board of County Commission on December 21, 2021.
- Turkeys were given to all staff for Thanksgiving, and everyone was very appreciative.
- A Geriatric Outpatient Psychiatric program will be implemented in January 2022. The program is being housed on the grounds of the hospital and will benefit from the Hospital's Critical
